REGIONAL TRANSIT AUTHORITY OF SOUTHEAST MICHIGAN (RTA)

Authorizing the Regional Transit Authority of Southeast Michigan (RTA) to levy within Macomb, Oakland, Washtenaw and Wayne counties a property tax assessment at a rate of 1.2 mills (\$1.20 per \$1,000 of taxable value) for 20 years beginning in 2016 and ending in 2035. It is estimated that \$160,907,285 will be collected in the first year.
