### City Manager's Report

#### **Other Business**

Commissioner Rubino discussed concerns regarding the cost of the water bills. He would like to schedule a town hall meeting and do a presentation to the voters. Decide if some of the costs from the water bills should be transferred to the tax rolls. Discussions should be held regarding moving the 12 towns debt, which is 1 mill and the levying and addition 1 or 2 mills.

City Manager Ball recommended that this item should be given to the voters. The earliest this language can be approved and place on a ballot is August 2013. Her recommendation is that the millage question be placed on the November 2013 ballot.

Commissioner Bushey agrees that the water issue should be presented to the voters. He would like the City Manager to begin to prepare ballot language so that is can be approved.

Commissioner Perry commented that Mr. Hartman's model is a hybrid model of water billing, between fixed versus variable. This may be an alternative that could be discussed at the proposed town hall meetings.

Commission Rubino commented that he felt the hybrid model would be discussed.

Commissioner Perry requested an additional workshop regarding water issues for the City Commission.

Commissioner Bushey commented that he felt the City Commission had decided what to present to the voters at the last workshop. He would not like to delay this item getting to the voters. Commissioner Bushey supports the current method of water billing, however, feels it should be given to the voters.

Commissioner Krzysiak commented that he supports Commissioner Rubino's request for town hall meetings for the residents regarding the water issue. Would like to see information available at the meeting and online. Feels that the voters should decide this issue.

### 13-2936

Motion by Commissioner Bushey, second by Commissioner Rubino, that the City Administration begin to develop ballot language for City Commission approval, regarding the transfer of certain water costs to the tax rolls and that a Community Town Hall meeting regarding this issue be scheduled for March 2013.

Commissioner Krzysiak commented that he would like to see the City develop a Human Rights Ordinance. The City of Royal Oak is drafting this ordinance.

Mayor Castelli suggested the City Administration should obtain a copy of the adopted Royal Oak ordinance prior to developing an ordinance for Pleasant Ridge.

Commissioner Kryzsiak agreed to wait for the Royal Oak ordinance. He commented he has never lived in a more accepting community than Pleasant Ridge. Feels this ordinance is a pronouncement of the acceptance and an announcement of who Pleasant Ridge is as a community.

Mayor Castelli commented that this ordinance was proposed by a former City Commissioner and withdrawn. Pleasant Ridge is a unique community.

With no further comments or discussion, Mayor Castelli adjourned the meeting at 8:48 pm
