Re: Gainsboro Park Fence Line

Attached is an estimate for fence repair and/or replacement at Gainsboro Park. Also included in your materials is a comprehensive analysis of the fence condition from Kensington to the southern border.

A few quick notes to keep in mind when looking at the information:

Quote #1 is based on a time & materials basis - but the fence contractor and our engineers think that it will be around \$10,000-\$15,000. If this option is selected, we can handle this as a maintenance issue and an extension of recent fence work that our engineers have bid out in other nearby communities, meaning we could begin repairs as soon as the weather permits. This is an excellent price based on the market

Quotes #2 and #3 are for materials only, and do not include engineering, bidding, railroad permitting and coordination, and construction management costs. Those soft costs typically end up adding up to an additional 10-20%, so as you look at the numbers for options 2 and 3 please add 20% to the quoted price. These projects and prices are far more substantial and would have to be competitively bid, so it would be summer at the earliest before we could get the work done.

I will present the materials so you will be educated about the fence and its condition. The City Commission has already reviewed & discussed the options.

Repair of existing fence, I feel a T&M situation would be the best way to handle, I think it would almost be impossible to detail to what extent the repairs would be considered complete.

One ton truck with basic hand tools	200.00 per day
2- Man crew based on 8 hour site time	1,250.00 per day
Wire, 72"2x9 gauge galvanized	3.71 per foot
1 5/8 top rail	2.14 per foot
9 gauge tie wires	15.00 per bag of 100
1 5/8 sleeves	1.50 each
10 lb. coil of 9 gauge smooth wire	30.00 each
6 foot tension bar	3.75 each
2 ½ x 10' 6" long line post	35.00 each
2 ½ x 1 5/8 loop cap	1.75 each

Best guess of time needed to accomplish repairs the owner may consider 4 to 5 days.

Option #2

Refurbish the existing chain link for approximant 610' this portion of the fence is currently located on the property line.

950' of new heavy commercial galvanized chain link to be installed on property line east of existing fence approximently 20' east.

Along this 950' area downed trees and brush will be removed and hauled away.

Once new fence is installed approximant 950' of existing fence will be removed and hauled away.

Total price of 59,528.00

Option #3

Remove approxamently 1560' of existing chain link fence, replace approx. 1560' of new 6 foot vinyl coated wire and power coated frame work (to be determined black or green) new fence is to be installed on property line. All tree removal and removal of downed brush and trees necessary to install fence is included.

Total price 83,285.00

Cost not covered in this quote. We are not sure what if any special insurance or inspection cost maybe necessary to work next to or within rail road right away.

Red: Fence requires replacement. This includes any of the following: All new fabric, new poles, new rail (remove existing).











