

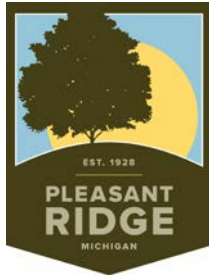

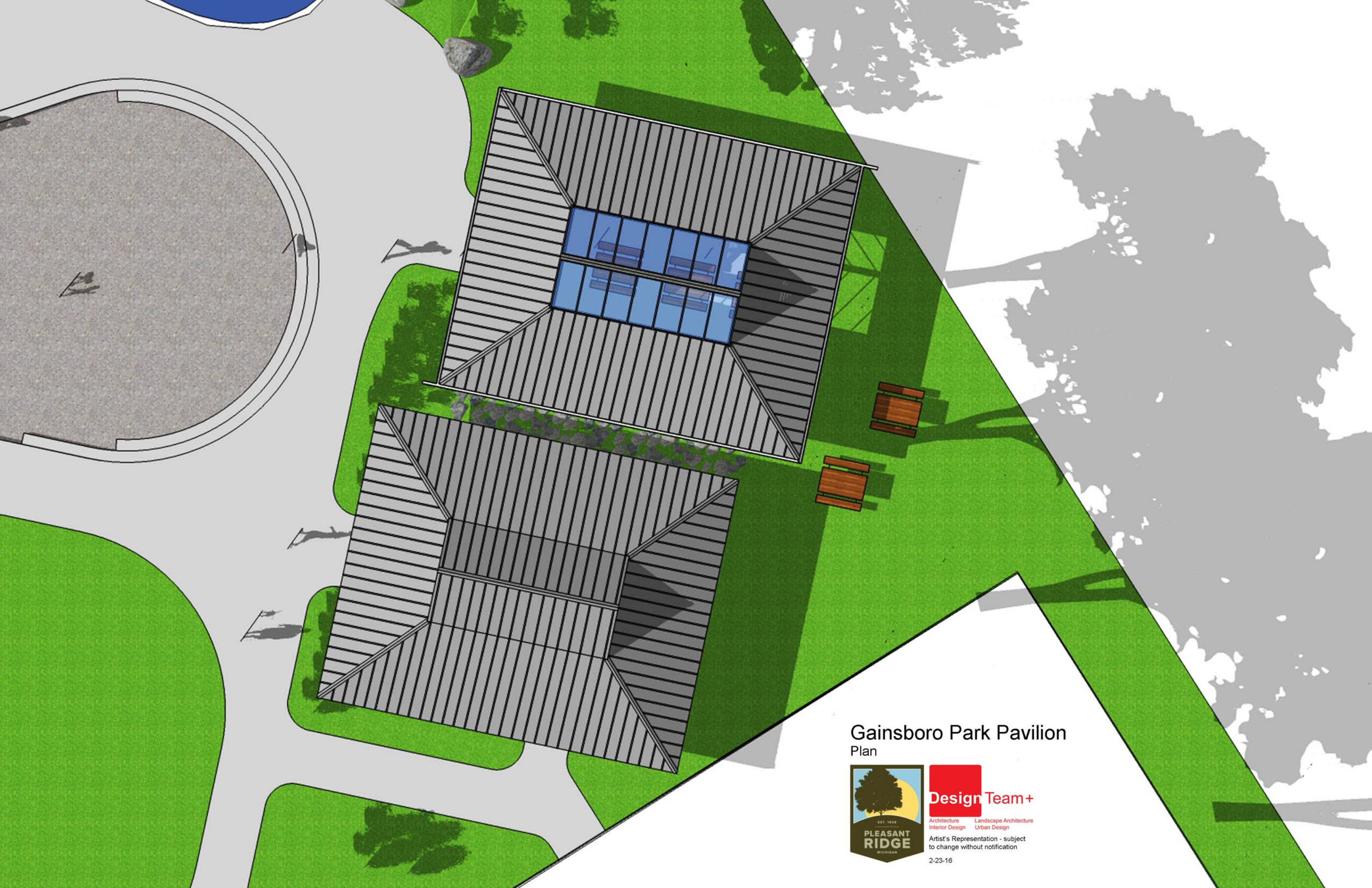

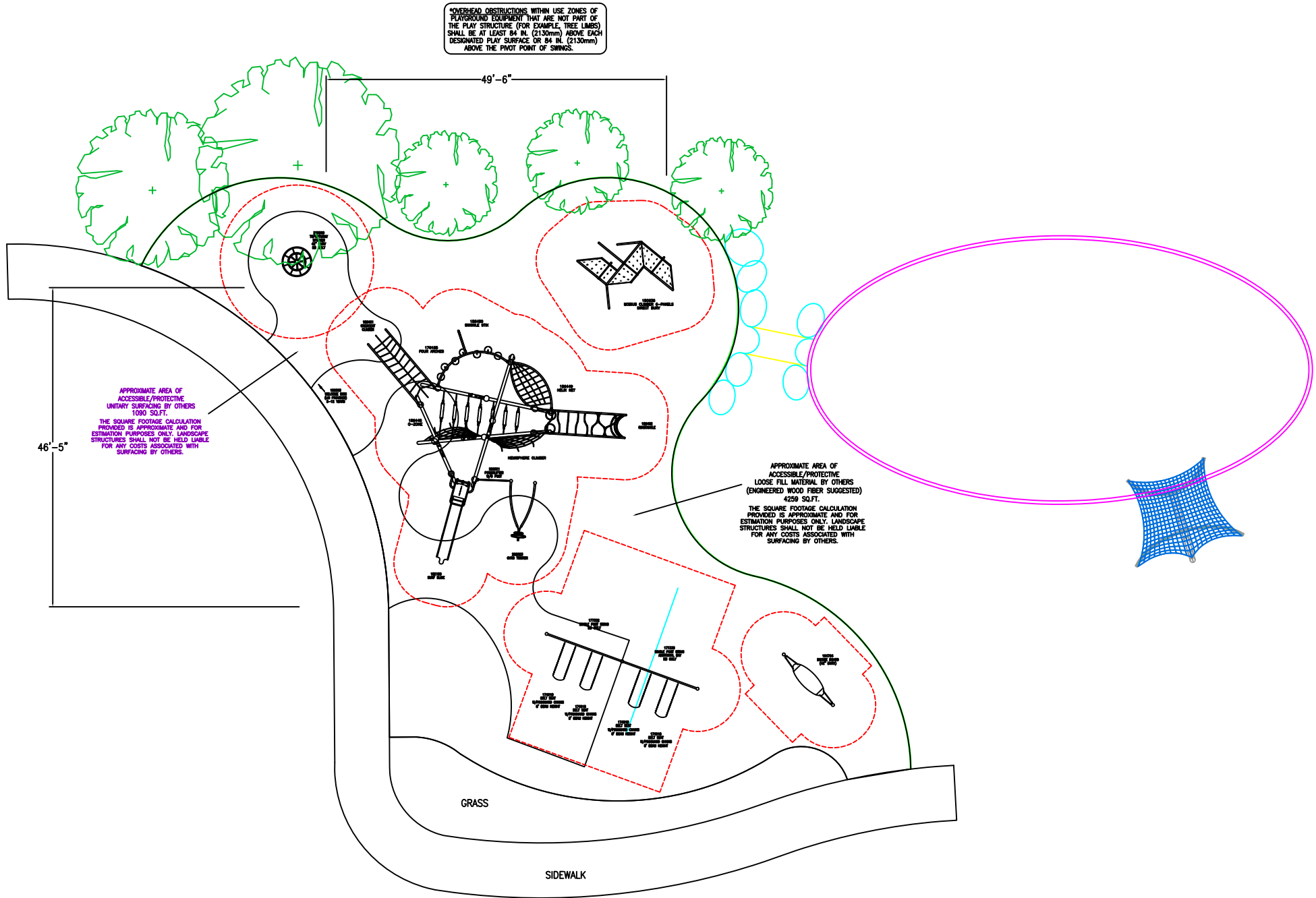


Gainsboro Park Pavilion

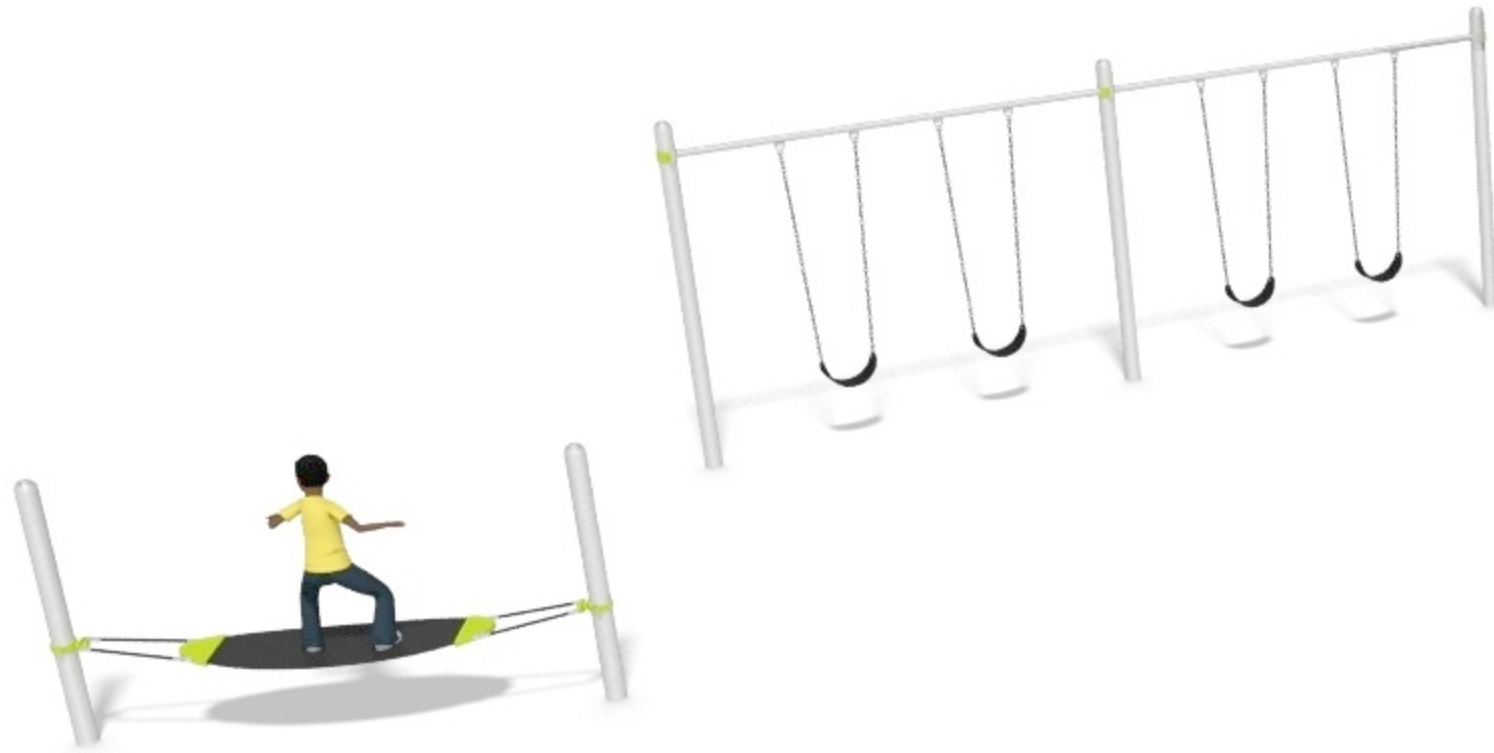
