New Member Recognition

City Manager James Breuckman introduced the new members, Mr. Kevin Barlow and Mr. Thomas Treuter. Chairman Lenko welcomed the new members. Nominations were taken from the Commission. The 2016 Planning Commission Organization will be as follows:

Other Business

Commissioner Treuter questioned if there was an update to the development at the Iron Ridge site.

City Manager Breuckman did not have an update. The developers are working behind the scenes. They are going to need a Brownfield plan, more than likely through Oakland County and that plan will require City Commission approval. As far as the Planning Commission, unless they require Special Use approval the Planning Commission will not be involved.

Commissioner McCutcheon questioned the remediation at the Reichhold site.

City Manager Breuckman commented that site is under continued monitoring and unless it will be developed, it will not be considered fully remediated.

Commissioner Christensen questioned what the Brownfield plan does.

City Manager Breuckman commented that Brownfield plan allows owners to capture the incremental increase in taxes of their property to pay for the environmental cleanup of the site. Once the owner is "paid back" for their work that capture ends.

With no further business Chairman Lenko adjourned the meeting at 7:10 p.m.
