Re: Gainsboro Park Basketball Rims

At the April 2017 Recreation Commission meeting the Commission voted to keep the lock on the basketball rim at Gainsboro Park.

The motion read: I move to Lock the Hoop until further notice, staff can unlock for future special events & explore future possible opportunities at the site. It was a unanimous vote.

At this time staff is asking to reopen the court with the following policy and gameplan as described in the rest of the memo.

Basketball Court Closure Policy

This verbiage along with a park rules sign, will be posted near the basketball court.

All users of the basketball court must follow the park rules. Refer to the sign attached to the tennis court fence (Attached).

We also expect basketball players to not harass other users of the park. There is a shelter building with restrooms on the other side of the tennis courts. Use it, not the bushes to relieve yourself. Be respectful of other basketball players and park users.

If we continue to experience issues or receive complaints about problems at the basketball court, we will lock the rims again. If we are forced to lock the rims multiple times, we will consider removal of the basketball hoop entirely. We understand that most of the people using this court are not to blame for these problems, but all basketball players are expected to behave like decent people.

CLOSURE SCHEDULE

- If 3 or more of any of the above rules or incidents are reported to the City in a rolling 14 day period, the rim will be locked for an unspecified amount of time.
- If the rim has to be locked 3 or more times during a rolling a 1 year period, it will be recommended to the Recreation Commission for permanent removal.

If approved, the administration would only come back to the Recreation Commission for additional action if the 3 lock ups in one year occurred. I would not plan to ask the Recreation Commission for the individual lock ups.

Recommended Motion: I move that the recommended Basketball Court Policy and closure schedule be approved and that a park rules sign and court guidance sign be hung up near the rim.
