TO THE QUALIFIED ELECTORS OF CITY OF PLEASANT RIDGE:

PLEASE TAKE NOTICE that any qualified elector of City of Pleasant Ridge who is not already registered, may register to vote at the office of the City Clerk; the office of the County Clerk; a Secretary of State branch office, or other designated state agency. Registration forms can be obtained at mi.gov/vote and mailed to the City Clerk. Voters who are already registered may update their registration at www.expressSOS.com.

The last day to register in any manner other than in-person with the local clerk is **Monday, October 5, 2020.**

After this date, anyone who qualifies as an elector may register to vote in person with proof of residency (MCL 168.492) at City of Pleasant Ridge Clerk's office, located at 23925 Woodward Avenue, Pleasant Ridge, Michigan at the following times:

- Regular business hours: Monday through Thursday from 9:00 a.m. to 4:00 p.m.
- Saturday, October 31st from 9:00 a.m. to 5:00 p.m.
- Election Day, Tuesday, November 3rd from 7 a.m. to 8 p.m.

AND FOR THE FOLLOWING PROPOSALS:

State Proposal 20-1 – A proposed constitutional amendment to allow money from oil and gas mining on state-owned lands to continue to be collected in state funds for land protection and creation and maintenance of parks, nature areas, and public recreation facilities; and to describe how money on those state funds can be spent.

State Proposal 20-2 – A proposed constitutional amendment to require a search warrant in order to access a person’s electronic data or electronic communications.

County Proposal – Oakland County Parks and Recreation Millage – Millage Replacement and Increase to Improve, Operate, and Maintain Parks, Open Space Areas, Trails, and Recreation Activities in Oakland County, Michigan.
