Re: DDA Planter Program

We have purchased a few sample planters and will review those with you at next week's meeting. Our goal is to implement the planter program this coming spring. Our next steps will be to determine the final selection of planters that we will offer, and how the specifics of the program will work.

### **Planter Selections**

Following is a list of the planters we purchased for review. The planters are all square or round, but they have coordinating or matching rectangular planters if we want to offer rectangular options along with round or square ones.

## **Draft Planter Program Guidelines**

#### Planter Selection:

- <u>DDA Provided Planters.</u> The DDA will provide planters chosen from our pre-selected list. The DDA will fill the planters with dirt. At the property owner's option, the DDA will also provide plant materials for a cost of \$\_\_.
- <u>Property Owner/Business Provided Planters.</u> Property owners who wish to use a different planter in the right of way that is not on the DDA's planter list may do so at their own cost, so long as the planter meets the location and design criteria. The planter and location must be approved by the City prior to installation.

### Planter Location Criteria:

- Height. Planters located in the right of way may have a maximum height of 24 inches.
- <u>Clear Sidewalk Area</u>. Maintain clear, unobstructed passage along the sidewalk. Planters must be set back at least one foot from the sidewalk, either on the building side or the street side.
- <u>Curb Separation.</u> Maintain minimum 1.5-foot separation between the curb and the edge of planter.
- Plant Materials and Visibility.
  - Plant materials shall be chosen to maintain unobstructed views for drivers. This is more important at the north end of blocks, as drivers will be looking south to view oncoming traffic on Woodward.
  - Planters and plant materials shall not obstruct views of buildings, or unduly block views of pedestrians on sidewalks. Tall plants may be used periodically in planters.
  - o Planters should contain plants that overflow and spill down the sides of the planter.
  - o Bold use of color is encouraged
  - o Planters should be full of plants. Weak plantings will be lost in the Woodward environment.

### **Next Steps**

The next steps are for the DDA to provide input on the sample planters and program guidelines. Staff will then finalize the list of options and the program guidelines and roll out the program to our business owners.
