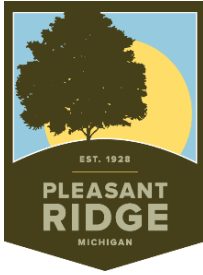

**Regular City Commission Meeting  
February 13, 2018**

Having been duly publicized, Mayor Metzger called the meeting to order at 7:31 p.m.

**Public Discussion**

**Governmental Reports**

Chief Kevin Sullivan, Ferndale Fire Department, noted that there were four retirements at the end of 2017 including the Fire Marshall. Three new people have been hired this month which will mean that there will be seven people in the Department with one-year experience or less. There are now three positions to fill. The number of applicants has dropped significantly.

Chief Kevin Nowak, Pleasant Ridge Police Department, noted that residents are required to clear their sidewalks. He also noted that pushing the snow into the street is not permitted. It would also be helpful if residents removed their cars from the street, even if a snow emergency has not been declared. He reminded everyone that garbage day is Monday. Cans should not go out before 6:00 p.m. on Sunday and they should be removed within 12 hours of collection.

**City Commission Liaison Reports**

Commissioner Krzysiak reported on Ferndale Public Schools. Suburban Ford of Ferndale hosted a "drive for your school" event. The event raised \$3900 for camp scholarships and other school programs. University High School teachers and administration developed a new program called Target Time to help students recover and make progress after disappointing test scores. In the most recent session, 158 students participated and 67 of them remediated their failing scores and achieved passing grades. Two Ferndale Middle School students, Ruby Speedwell and Tiana Bartley, had their artwork displayed at the Student Art Town Exhibition. Ms. Bartley's photo won second place out of all the middle school students in metro Detroit. Ferndale Schools received a grant from DTE for LED exterior lighting which will result in savings of \$8600 per year. Spanish will now be offered in sixth grade. The Superintendent will attend the March City Council meeting to discuss the district's strategic planning process. The Superintendent challenged the students to send her a photograph of them reading on their recent snow day. The Commissioners brought their own books and took a picture to send to the Superintendent as well.

Commissioner Perry reported on the Planning Commission/DDA. The Planning Commission had a public hearing on February 5th for special land use for the Sunoco gas station which is now permitted to sell beer and wine beginning this month. They reappointed the Chair, Vice Chair and Secretary. The DDA held a new year gathering of local businesses which was very well attended including people from Iron Ridge. They also discussed adding decorative planters. The next meeting is February 26th. Updating the Woodward streetscape will be on the agenda. The existing streetscape is 30 years old.

Commissioner Scott reported on the Historical Commission. There was a special meeting in February regarding the 100-year home plaques. The lighting has been installed at Stevenson Park. Next meeting is March 7th.

Commissioner Wahl reported on the Recreation Commission. The Recreation Commission met on January 31st and discussed the community garden. It is sold out and ten additional plots are being added. The Daddy/Daughter dance was a success with 40 couples participating. Applications for summer counselors and life guards are due by March 2nd. St. Patrick's Bingo is March 8th. The egg hunt and pancake breakfast is March 24th at 10:00 a.m.

City Manager Breuckman indicated that these ordinance amendments have been requested by the police department. Some are the result of recent changes in state law. The false alarm amendment is intended to encourage residents to address the underlying cause of frequent false alarm calls. It also sets some standards regarding audible alarms. The second ordinance specifically deals with storage of unlicensed or inoperable vehicles which were previously only covered by the general nuisance ordinances. It excludes vehicles stored in garages and only addresses vehicles in yards or on the street. The two OUI ordinances are housekeeping matters to match changes in state law.

Commissioner Krzysiak asked how many times the vehicle storage issue has had to be addressed. The Deputy Chief noted that the occurrences have been fairly rare. The issue is usually corrected by the

homeowner without the need for ticketing. Chief Nowak indicated that a more specific ordinance would be very helpful especially when there are multiple nuisance issues at a particular residence. He also noted that CLEMIS can now track false alarm reports. There was a discussion regarding the process and necessity of responding to alarms. The fees and fines applied to false alarms were also discussed. City Attorney Need noted that three false alarm calls can occur without penalty.

**City Manager's Report**

City Manager Breuckman presented the MParks design award for Gainsboro Park. Construction bids have been solicited to reconstruct Ridge, Indiana and Bermuda. He presented slides for some of the proposed construction projects including improving the crosswalk near the school. Indiana, Ridge and Bermuda will be redone with asphalt which is less expensive and quicker to install. The intersection with Sylvan will be concrete to match the existing road. Colored concrete will be installed to highlight the crosswalk. These will be primarily summer projects that will be presented for approval at the March meeting. The permeable asphalt at Kensington is performing well.

**Other Business**

Commissioner Krzysiak noted that February's book, *Underground Railroad*, by Colson Whitehead is very powerful and will be discussed at the February 14th meeting. The March book will be *Unconventional Leadership*, by Nancy Schlichting, the CEO of Henry Ford Health System.

With no further business or discussion, Mayor Metzger adjourned the meeting at 8:22 p.m.

I write today regarding evangelistic work that the Family Health and Education Resources ministry of the Seventh-day Adventist Church will soon be conducting in your community. Student literature evangelists will soon be going door-to-door distributing free religious literature, praying with community members, enrolling interested individuals in Bible Studies, and seeking donations to support the program.

The Literature evangelistic program of the Adventist Church has been in existence for well over 100 years and is an important part of the Church's missionary work and evangelism. As student literature evangelists they are following the Great Commission that Christ gave His followers in Matthew 28:18-20.

In order not to disturb the community or be bothersome this program usually runs from 10:00am to 9:00pm, June 3 – August 11. Further, all of our students carry identification recognizing them as part of the Family Health and Education Resources Program. They also carry radios or cell phones to contact their onsite leader who can provide more information while in the field.

Some communities have ordinances governing door-to-door sales, canvassing or solicitations. However, the Supreme Court has protected door-to-door advocacy based upon the free exercise and speech clauses of the First Amendment. The Court has been particularly suspicious of any prior restraint on these activities such as requiring permit or registration process. If your city has an ordinance that it believes applies to our activities I ask that you contact us as soon as possible so we can discuss this.

We believe our evangelistic activities fall squarely within the protected zone of the First Amendment. Unless we hear differently we do not plan on applying for any permit or registering prior to beginning our missionary work.


It is our desire to work with local communities to avoid any potential problems. We are happy to provide more specific information regarding the program if you desire.

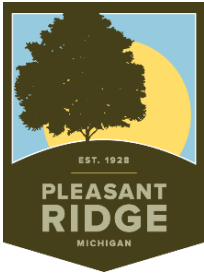

### Overview

The following budget amendments adjust property tax and municipal fine revenue estimates; increases contribution revenue; and accounts for increased wage, contractual service, and capital project expenditures.

### Background

#### Budget Amendment Group 1 – General Fund

We have adjusted our property tax administrative fee and municipal fine budgets to be more in line with actual and historical revenue activity in these accounts.

Miscellaneous expenses have been increased to cover the commission approved payroll expenditures.

The audit budget has been increased for actuarial services that were needed to comply with a new accounting pronouncement (GASB 67/68) pertaining to post-retirement benefits. Also in the audit contract line item were unanticipated expenditures related to a new audit requirement to have a performance audit on our street funds (PA 298). These expenditures have since been reimbursed by the State. The amendment to the current budgeted amounts is as follows:

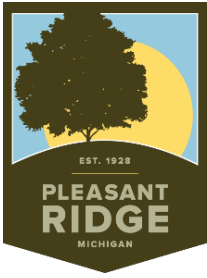

- WHEREAS,** *we believe children in Pleasant Ridge are no less at risk than anywhere else in the country.*

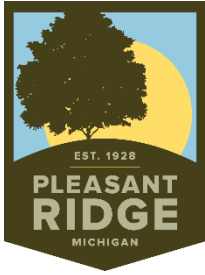

Re: City Code Amendment Introductions – Police Ordinances

## Overview

Attached are four ordinances to amend the City Code for various purposes. The ordinances were requested by the Police based on their experience as they work to address the day-to-day issues in the City. A public hearing was established at the February meeting. Notices have been posted and publication has been completed as required.

## Background

The ordinances for introduction are:

1. **Section 14-136 through 143: False Alarms.** This ordinance establishes a process by which the police can address two issues that we have dealt with in the past:
  - a. Audible alarms disturbing the peace. The ordinance requires that the owner of any alarm with an audible alert sound register their contact information with the police so that we can quickly contact them if an alarm is sounding. We have had instances where a business alarm was going off in the middle of the night, disturbing neighbors.
  - b. Response to false alarm calls. There have been instances where there are recurring false alarms from the same house or business in the City. Responding to false alarms is a drain on police resources. It is reasonable to expect that there will be some false alarms that are triggered, but the issue is that sometimes false alarms recur at a specific house or business and the owner or resident does not remedy the situation. This ordinance will give the police recourse to fine the owner if continuous false alarms are triggered and the owner or resident does not remedy the situation.

There are provisions in the ordinance to account for false alarms triggered by circumstances outside of the control of the property owner or resident. These instances will not be counted as a false alarm.

2. **Section 34-52: Unlicensed Vehicles.** An issue which is not frequent, but does recur periodically is the accumulation of unlicensed or inoperable vehicles on private property. These are often stored

in backyards, and it is something that can create blight in a city like ours where we have small lots and small backyards.

We have dealt with these situations in the past using our general nuisance standards, but we will be better served by having a specific ordinance that prohibits the storage of unlicensed or inoperable vehicles.

Note that the unlicensed/inoperable vehicle provision does not apply to a vehicle that is stored in a garage. For example, a resident may have a project car they are restoring, or an extra car that they are storing for whatever purpose. If these cars are located in a garage it does not create the same blighting impact as such vehicles stored outdoors.

3. **Section 70-21: Michigan Vehicle Code Violations and Penalties.** This amendment would increase the maximum fine in subsection c from \$700 to \$1,000. This is to keep our local ordinance consistent with the Michigan Vehicle Code section 257.625, which was recently amended.
4. **Section 70-86 through 88: Cost Recovery for Prosecution Expense.** This ordinance adds cost recovery provisions for legal services incurred in the prosecution of traffic offenses. This will cover costs for OWI (operating while intoxicated) cases, but will not be levied against civil infractions such as speeding, failure to stop, impeding traffic, etc. This reimbursement of legal costs for OWI is standard practice for OWI prosecutions in Pleasant Ridge and across the state, so adding this section will not represent a substantive policy change.

This amendment also includes small revisions in Section 70-86 and 70-87 to change references to the City finance officer or office, given that we have outsourced our finance function and no longer have a finance officer.

## Requested Action

AN ORDINANCE TO AMEND THE CITY OF PLEASANT RIDGE CODE OF ORDINANCES,  
CHAPTER 14 – BUILDING AND BUILDING REGULATIONS.

THE CITY OF PLEASANT RIDGE ORDAINS:

**Section 1. Amendment.**

The Code of Ordinances will be amended by adding the following Code Chapter 14, Article VII - False Alarms:

**Article VII - FALSE ALARMS**

**Sec. 14-136. Definitions.**

The following words, terms and phrases, when used in this chapter, shall have the meanings ascribed to them in this section, except where the context clearly indicates a different meaning:

*Alarm system* means any mechanical or electrical device which, when activated, emits a sound or transmits a signal or message to which the police or fire department may be summoned, directly or indirectly, to respond. An alarm system is designed for use for one or any combination of the following:

- (a) The detection of an unlawful entry or attempted unlawful entry into a building, structure or facility;
- (b) The alerting of others of the commission of an unlawful act within a building, structure or facility; and/or
- (c) The detection of fire, smoke or heat within a building, structure or facility.

*Alarm user* means any owner or occupant who has physical control over the premises where an alarm system is installed within the city, except for alarm systems on motor vehicles. However, if an alarm system on a motor vehicle is connected to an alarm system at a premises, the person using such system is an alarm user. Excluded from this definition and coverage of this section are persons who use self-contained alarm systems, i.e., a system which signals or alerts other authorized persons who are on the premises of an attempted unauthorized intrusion, holdup attempt or fire condition. However, if such a system employs an audible signal emitting sounds, flashing light or beacon designed to signal persons outside the premises; such system shall be within the definition of an alarm system and shall be subject to this section.

*False alarm* means activation of an alarm system through mistake, mechanical failure, malfunction, improper installation, lack of prudent maintenance or through the negligence of the occupant of the residence and/or building in which the alarm system is located, including their employees or agents. The term “false alarm” also means any activation of an alarm system which indicates a crime or situation other than that which it was designated to indicate, or in the case of a fire alarm, any alarm condition not resulting from a fire or potential fire hazard.

**Sec. 14-137. Licensing required.**

No person shall engage in the business of providing for the installation, operation and/or maintenance of a burglar and/or fire alarm system and/or a combined alarm monitoring-sales facility unless properly licensed pursuant to Public Act No. 330 of 1968 (MCL 338.1051 et seq.).

**Sec. 14-138. Audible or visual alarms.**

- (a) *Signal disturbing the peace.* No person shall maintain an alarm system which, when activated, causes an audible and/or visible signal which can be heard or seen outside the premises and which is disturbing to the peace and quiet of the surrounding area, unless that person has first provided the police department with the following: their name, telephone number, address of the alarmed premises, and the name and telephone number of one other person who, having access to the alarmed premises, can be contacted at any time and can respond within 30 minutes to deactivate the audible and/or visible signal.
- (b) *Duration of external signal.* No person shall use, install, or direct to be installed, any audible alarm system which emits a sound alarm for a period longer than 15 minutes from the time of the initial sounding of the device.

**Sec. 14-139. False alarm fees.**

Notwithstanding any penalties provided for upon conviction for any violation of this chapter, and notwithstanding the fact that prosecution for violation of this chapter has or has not commenced, any person operating an alarm system which signals more than three false alarms as defined in section 14-1 within one calendar year shall pay to the city a false alarm fee in order to defray a portion of the cost of response to false alarms as follows:

- (a) Fourth false alarm .....\$100.00
- (b) Fifth false alarm .....\$200.00
- (c) Sixth false alarm and above .....\$300.00
- (d) All additional false alarm in the same calendar year \$500.00

**Sec. 14-140. Exceptions to alarm fees.**

Alarm conditions existing under the following circumstances shall not constitute a false alarm and no fee shall be assessed.

- (a) If measures to correct alarm system malfunctions have been instituted within a 72-hour period with notification to police department, provided that the alarm user presents, within 30 days of the date of alarm response, documentation of repair service having been performed by the alarm company to remedy a malfunction;
- (b) Alarm conditions being activated by a person working on the alarm system with prior notification to the police department; and
- (c) Alarms which can be substantiated as being activated by disruption or disturbance of telephone company facilities, or motor vehicle/utility accidents or by storm conditions.

**Sec. 14-141. Waiver request.**

- (a) Within 30 days of the date of an alarm violation, an alarm user wishing waiver of a false alarm and the associated fee as a result of a condition described in section 14-140, may do so by a written waiver request.
- (b) The waiver request, directed to the police department, shall contain documentation of the applicable condition as described in section 14-140
- (c) The police or fire chief, or a designated representative shall make a determination on the waiver request and shall notify the alarm user of the decision in writing.
- (d) In the event that the alarm user is not satisfied with the decision rendered by the police or fire chief or a designated representative, the alarm user, within ten days of the date of the determination of the police or fire chief, may file with the city manager or designee a written request that the determination be reconsidered.
- (e) The city manager or his designee shall decide whether to uphold or set aside in whole or in part, the decision reached by the police or fire chief. The alarm user shall be notified of that decision in writing. If the alarm user feels it necessary to appeal the decision he may have the opportunity to personally be present and be heard on the matter by the city manager or his designee.

**Sec. 14-142. Defective alarms.**

An alarm system signaling more than five false alarms within a calendar year is presumed to be defective. Upon written notice, the owner or occupant of

the building or residence shall have the alarm system inspected by a licensed alarm system contractor within ten days and shall forward to the police department said contractor's report of the probable cause of the false alarms and the measures instituted to eliminate same.

**Sec. 14-143. Penalty.**

- (a) Notwithstanding any other fees required by any other section of this chapter, any person who shall violate the provisions of this chapter shall be responsible for a municipal civil infraction, subject to the following penalties:
  - (1) *Fines.* The following civil fines shall apply in the event of a determination of responsibility for a municipal civil infraction, unless a different fine is specified in connection with a particular ordinance:
    - (i) *First offense.* The civil fine for a first offense violation shall be in an amount of \$75.00, plus costs and other sanctions, for each offense.
    - (ii) *Repeat offense.* The civil fine for any offense which is a repeat offense shall be in an amount of \$150.00, plus costs and other sanctions for each offense.
  - (2) *Enforcement.* In addition to ordering the defendant determined to be responsible for a municipal civil infraction to pay a civil fine, costs, damages and expenses, the judge or magistrate shall be authorized to issue any judgment, writ or order necessary to enforce, or enjoin violation of this chapter.
  - (3) *Continuing offense.* Each act of violation, and on each day upon which any such violation shall occur, shall constitute a separate offense.
  - (4) *Remedies not exclusive.* In addition to any remedies provided for by this chapter, any equitable or other remedies available may be sought.
- (b) The judge or magistrate shall be authorized to impose costs, damages and expenses as provided by law.

- b. The vehicle so stored or parked, whether currently validly licensed or not, is inoperable for any reason for a period in excess of five calendar days.

Upon receiving notice of a conviction, a plea of guilty, or a plea of nolo contendere for violation of MCL 257.625(1), (3), (4), (5), (6) or (7) or MCL 257.625a—257.625g, 257.625m of the Michigan Vehicle Code, the city manager or designee shall submit a bill for the expense of the emergency response, by first class mail or personal service, to the person liable as enumerated in this article. Payment shall be required within 30 days from date of service.

**Sec. 70-87. - Failure to pay.**

Failure to pay the bill submitted by the city' within 30 days of service shall render such matter in default. The city may then commence suit against the person liable to recover the expense of the emergency response and costs incurred in the collection process.

**Sec. 70-88- Reimbursement of expenses for emergency response and prosecution.**

Revise subsection (b) to add a new subsection (3) as follows:

(b) The expenses for which reimbursement may be ordered include all of the following:

(1) The salaries or wages, including overtime pay, loss of equipment, of law enforcement personnel for time spent responding to the incident from which the conviction arose, arresting the person convicted, processing the person after the arrest, preparing reports to the incident, investigating the incident, and collecting and analyzing evidence, including, but not limited to, determining bodily alcohol content and determining in the presence of and identifying controlled substances in the blood, breath, or urine; and

(2) The salaries, wages, or other compensation, including overtime pay, of fire department and emergency medical service personnel for time spend in responding to and providing fire fighting, rescue, and emergency medical services in relation to the incident from which the conviction arose.

(3) Costs billed or to be billed to the City for legal services associated with the issuance of a complaint and warrant, investigation, response to discovery, subpoenaing of witnesses, preparation for trial, preparation of pleadings, response to motions and pleadings, court appearances and court time, telephone calls and conferences relating to prosecutions and any other services performed in connection with prosecuting the person.

## Overview

The City received five bids for the reconstruction of Ridge, Indiana and Bermuda. James P Contracting was the low bidder at \$628,572.14 for the base bid, however their bid was non-responsive to the bid specifications because they submitted a bid bond in lieu of the required certified check. For that reason, AEW is recommending that the City accept the second low bid by Pro-Line Asphalt in the amount of \$648,178.98.

The total bid with alternates is \$703,702.98

## Background

Ridge, Indiana and Bermuda are the final streets to be reconstructed as part of the City's ongoing infrastructure improvement project. Once these streets are reconstructed, all of Pleasant Ridge's streets will have been reconstructed since the project started in 1995.

The lowest responsive bid for the project was submitted by Pro-Line Asphalt. The total bid including all alternates came in at \$703,702.98. The bid is only slightly higher than the City Engineer's cost estimate of \$695,228.70 for the project. The City Engineer has experience working with this contractor and is recommending that the City Commission accept their bid.

## Alternate Bid Options

The City Commission must decide if it wishes to accept any or all of the alternates that were included in the bid. The alternates are to narrow the intersections of Oakland Park, Elm Park, and Poplar Park at Ridge. Currently, the streets are 36 feet wide at Ridge. The alternates would narrow this to 28 feet, which is more in keeping with the 27-foot width of a regular, non-boulevard street. Narrowing the intersections will still allow for all vehicle movements, while shortening the crossing for pedestrians, increasing pedestrian safety and visibility.

The City conducted a test of the narrowed intersection at Oakland Park and Ridge last fall. That test was designed with a 24-foot wide opening. We did receive a few comments that it was too narrow and difficult for drivers, so the opening was widened to 28 feet for the plans that were put out to bid. Narrowing the intersection to 28 feet will reduce the width of the intersection, and the time it takes for a pedestrian to cross it, by 23%.



Please refer to the attached page from the plan set, and representative aerial showing how the intersections would be narrowed.

The City Commission must decide if it wishes to accept the alternate bid options A, B, and C. Alternate A is for Oakland Park, B is for Elm Park, and C is for Poplar Park. The Commission may accept one, two, or all three alternates.

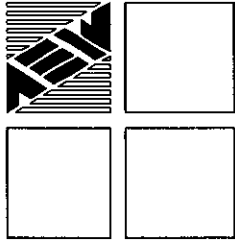
### **Project Schedule**

It is as yet unknown when the project will start. Work on Ridge Road may not begin before school lets out in June. Once the project is awarded we will work with the contractor to determine what schedule works best for them. The most likely options would be for the contractor either start on Indiana and Bermuda in the spring and then move to Ridge in late June after school lets out, or to wait until late June and work on all three streets simultaneously.

As per our standard practice, we will hold pre-construction meetings for residents before the projects commences to discuss details of the project schedule and what disruptions residents should expect.

### **Requested Action**

City Commission action to award the base bid for the construction contract to Pro-Line Asphalt for the total amount of \$648,178.98, and further to decide if the City Commission would like to award Alternate Bid Option A in the amount of \$18,485.00, Alternate Bid Option B in the amount of \$18,432.00, and Alternate Bid Option C in the amount of \$18,607.00.

The apparent low bidder is James P. Contracting, Inc. with a low overall bid of \$675,316.04. However, James P. Contracting, Inc., did not submit the required bid security per the bid documents. A bid bond was submitted in lieu of the required certified check. All other bidders provided a certified check. Based on this bid irregularity, James P. Contracting's bid is considered non-responsive and cannot be considered for contract award. Therefore, the responsible low bidder is Pro-Line Asphalt with an overall low bid of \$703,702.98.

Based on our experience and references provided, we recommend a contract for the **2018 HMA Resurfacing Project** be awarded to **Pro-Line Asphalt**, 11797 29 Mile Road, Washington, Michigan 48095 in the amount of **\$703,702.98**.

## Overview

The City of Ferndale is applying for two Transportation Alternatives Program (TAP) grants from MDOT, administered through SEMCOG. One is for nonmotorized improvements to Woodward Heights, and the other is for a regional bike share system in Southeast Oakland County and Northwest Detroit. The City of Pleasant Ridge is not an applicant for either of these grants, and if they are awarded we will not be participating in or funding either project. However, Ferndale has requested letters of support from us as we are directly adjacent to and located within the service area for each project.

## Background: Regional Bike Share

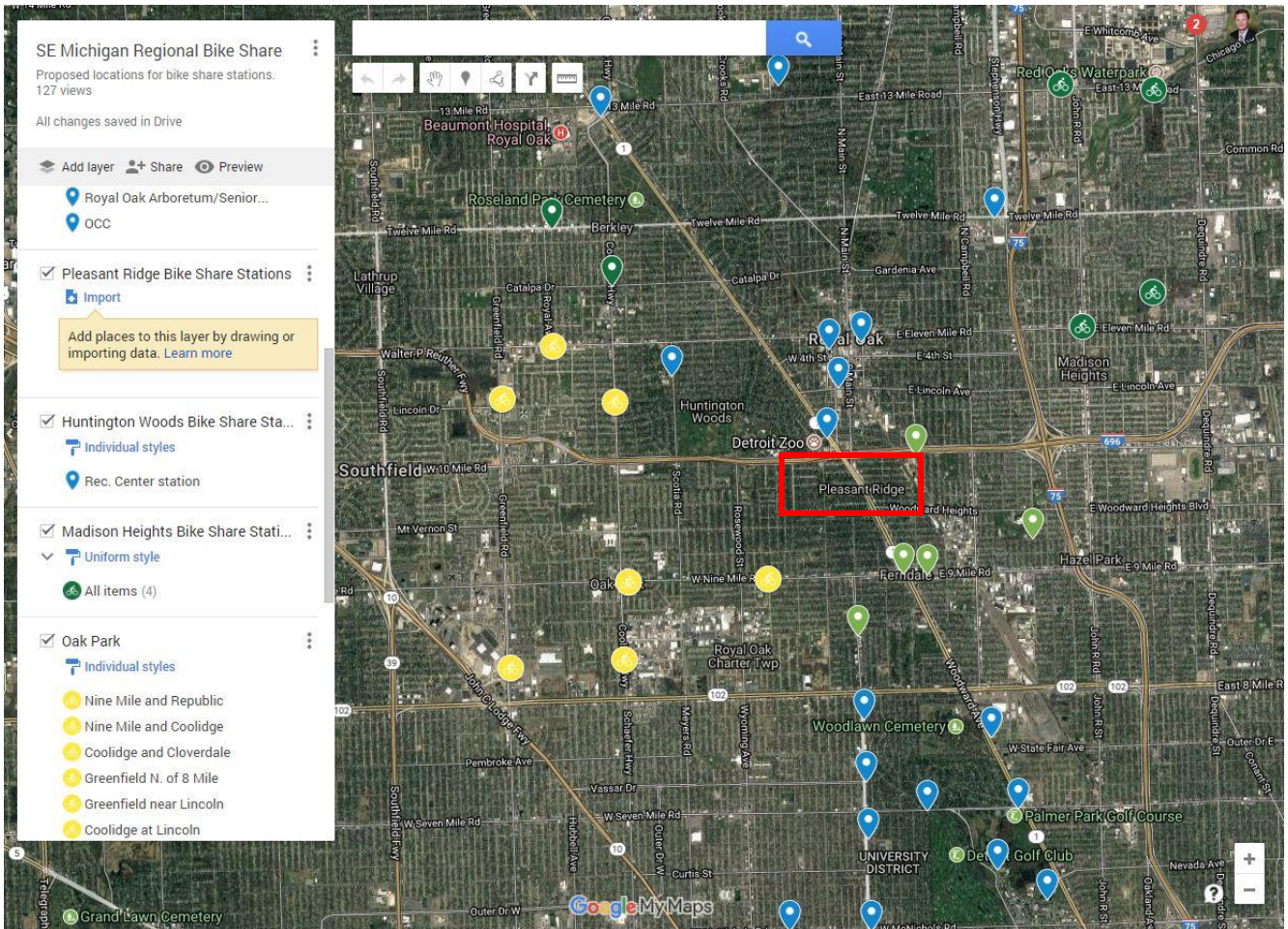
The proposed regional bike share system would be an extension of the MoGo system that recently launched in the greater downtown Detroit area. The docking stations for the bike share system would be publicly supported by each community. There is an installation cost for each station along with annual maintenance fees, so even with the TAP grant there would be startup and ongoing costs to participate in the system. Exact pricing is not known at this time, but each station will cost \$15,000 or more to install, depending on the size and features of the station.

At this time, Pleasant Ridge is not participating in the bike share system for the following reasons:

- Bike share programs are an important component in the regional effort to increase bicycling, particularly where there are centers of activity or employment.
- It is as important to create a well-connected regional bike infrastructure system that allows riders of all ages and abilities to safely and comfortably ride their bikes to and from destinations in our area.
- Pleasant Ridge has been supportive of efforts to increase bicycling in our local area, and believe that the effort by our adjacent and nearby communities to develop a bike share system will benefit all residents and businesses in our area.
- However, staff does not see a use case that would justify the significant upfront and ongoing maintenance costs for us to have a bike share station or stations within our City. We are primarily

residential in character, and the vast majority of trips in our City begin or end at a place of residence. This means that our residents can use their own personal bikes if they wish to. Our business district also does not have the use density to support or justify the cost of installing stations.

For reference, each community was asked to identify potential station locations. Please note that Huntington Woods and Madison Heights identified station locations, but have decided to not participate in the bike share system at this time. Pleasant Ridge boundaries are shown in red for reference.



As a final note, if the bike share system comes to fruition and is successful, we can add a station or stations in Pleasant Ridge at any time in the future.

### Background: Woodward Heights Non-Motorized Improvements

Ferndale is also applying for a TAP grant to fund bike lane improvements on Woodward Heights. Ferndale will be resurfacing Woodward Heights in 2019. The TAP grant would fund complete streets improvements in addition to the resurfacing.

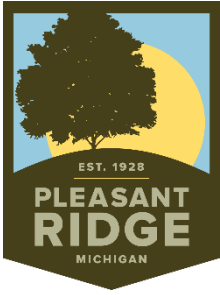
The Woodward Heights corridor is a primary connection for the existing regional bike route, including Pleasant Ridge, Royal Oak, and Hazel Park. The project includes Woodward Heights from Bermuda to Lennox and TAP funds are sought to provide high visibility crosswalks and a combination of buffered and

protected bike lanes (between Horton and Hilton). The project also includes constructing sidewalk along the south side of Woodward Heights from Burdette to Horton. Refer to the attached plan sheets for details about what is proposed with the project.

## **Requested Action**

City Commission consideration of a resolution of support for the two TAP grant applications. If a resolution of support is passed, we will transmit the attached letters to Ferndale for inclusion in their TAP grant applications.

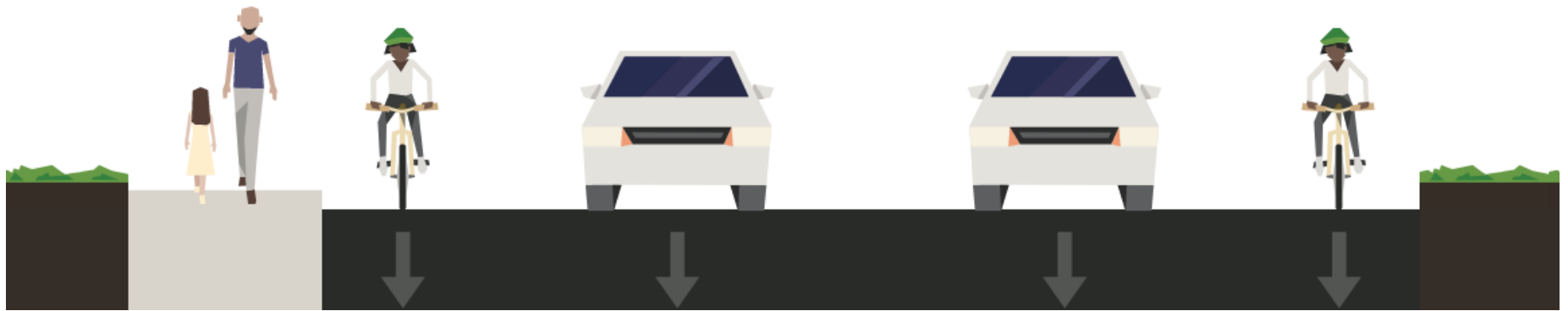

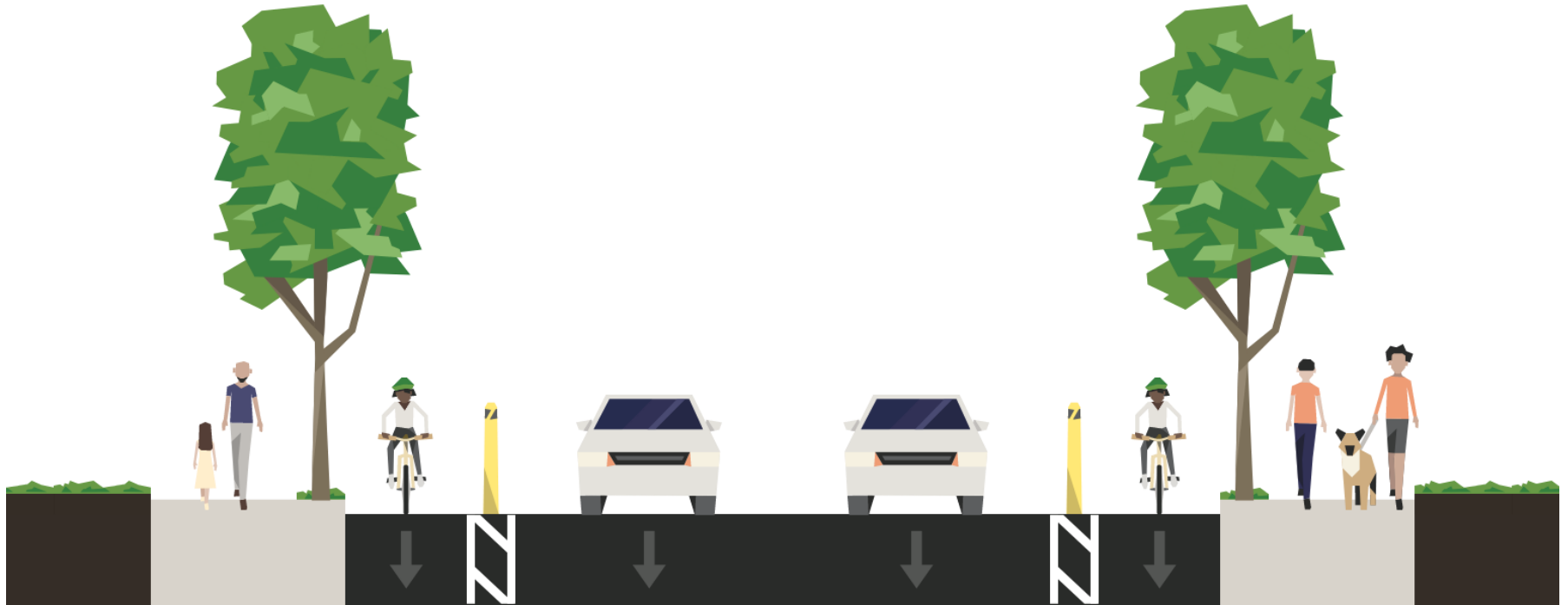
