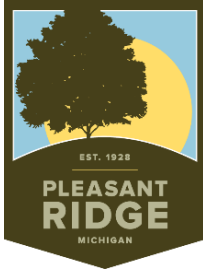

Introduction of new members

City Manager Breuckman introduced the new member of the Planning Commission/Downtown Development Authority Frederic McCoy.

Special Land Use – 23701 Woodward Avenue, Sunoco

City Manager Breuckman gave an overview of this request. At the December 11, 2017, Planning Commission Meeting, recommended that the City Commission adopted a proposed ordinance eliminating subsection m, allowing for gas stations to engage in SDM sales under the provisions of Section 82-197(b)(9) of the Pleasant Ridge zoning ordinance. The City Commission approved the Zoning Ordinance amendment that allows the owner of the Sunoco Station to request a special land use permit for SDM package liquor sales. He has applied for a special land use permit, which has been noticed accordingly. The request to add SDM liquor sales does not include any physical changes to the site. Therefore, site plan approval is not required. The site complies with all physical requirements of the Ordinance (setbacks and parking being the most notable ones). The proposed use will have to comply with the operational requirement of Section 82-197(b)(9) that limits the sale of package liquor to the hours of 9:00 a.m. to 10:00 p.m. Mr. Singh's letter indicates that the site will comply with this by using timed door locks on the beer coolers. Wine from the shelves is not proposed to be secured, but the store staff will be instructed to not sell wine outside of normal

hours. The Planning Commission should consider the special land use request, after the public hearing this evening.

Chairman Treuter opened the public hearing at 7:05 p.m.

Mr. Rob Sakat, 8 Fairwood, in favor of the Planning Commission granting the special land use so the owner of Sunoco can grow his business.

With no further comments or discussion, Chairman Treuter closed the public hearing at 7:06 p.m.
