DDA 2018-2019 Budget

City Manager Breuckman met with the DDA budget committee and discussed the proposed budget for 2018-2019. He gave a brief presentation of the highlights of the budget. The DDA budget is part of the full budget document, which is adopted by the Pleasant Ridge City Commission after a public hearing.

DDA Planter Program

City Manger Breuckman displayed four planter options for the DDA members to consider. Discussion was held as to what planter would fit best in the district. Discussion was held regarding

distribution and type of plants in the planters. Business owners in the DDA would be responsible for watering the planters once they are placed. The DDA members determined the large wide square opening planters would be selected in black and expresso. The planters will be filled with soil and delivered to businesses requesting planters. Two planters will be allowed per business.

Other Business

Commissioner Martin-Campbell questioned if there was any update regarding the Oakland Park/Sylvan/Woodward crosswalk and the possible painting of the crosswalks. Manager Breuckman discussed the construction of the Woodward crosswalks over the next season with MDOT. He has submitted a design plan to Oakland County Road Commission and MDOT which is currently being reviewed. There will be no changes to the Oakland Park/Ridge Road intersection.

Mr. Rob Sakat, 8 Fairwood, questioned who maintains the Blue Star Memorial at the corner of Woodward and Wellesley. The Pleasant Ridge Garden Club maintains that area. He commented the planters have not been planted as of yet this year and there is planting debris in those planters.

Commission Perry commented on the upcoming RTA meetings. The next meeting for Oakland County will be Wednesday, April 25, 2018 from 5:30p-7:30p, at the Baldwin Public Library in Birmingham.

Chairman Treuter attended the open house at the Men's Chair, 23908 Woodward Avenue.

With no further comments or discussion, Chairman Treuter adjourned the meeting at 7:47 p.m.

Re: Chariot Multi-Jurisdictional Transit Circulator

Overview

Over the past 18 months, Pleasant Ridge and the DDA have been in discussions about a potential transit circulator service that would operate within Ferndale and Pleasant Ridge. At this time, we have a new concept using a service called Chariot. Ferndale is requesting that we re-confirm the funding pledge of \$10,000 for the service that we had made last year when we were working on a previous version of this service. Please note that no money has been spent on this service to-date.

The service would operate from 4pm until midnight, Thursday through Saturday. One shuttle will be running always, with two shuttles running during the 5pm to 10pm peak hours.

The pilot period for this service will run for 7 months, starting in September of this year and continuing through March of 2019. Ferndale is using this service as a way to offset parking disruptions during the construction of their parking deck.

The City of Ferndale has entered into a contractual agreement with Chariot. Pleasant Ridge, if we participate in the service, would not have a contractual agreement with Chariot, rather, we would be paying Ferndale as a service provider to add two stops in Pleasant Ridge on the Chariot route.

Background

The project formerly known as the FabCab that we were working on with Ferndale in the early part of 2017 has seen a rebirth. Ferndale is now partnering with Chariot, a mobility company that is owned by Ford:


Chariot started in the SF Bay region and has recently begun servicing the Detroit area. They will be the operator for the new weekend shuttle service.

Here are some details about the new service:

• The service will start with Ferndale and PR, with a target start date of September 1 of this year. There will be a 7-month pilot period after which the results will be evaluated and we will decide if we are going to continue the service with or without alterations. This simplifies the start-up process.

- Ferndale is asking that we sustain our prior \$10,000 commitment from the DDA and City to pay for the Pleasant Ridge portion of the service. You'll recall that this \$10,000 was the commitment that we made last year for the FabCab shuttle, which eventually collapsed under the weight of the number of organizations involved.
- The service will be free to use for residents during the 7-month pilot period. The funding model and service fee will be evaluated at the end of the pilot period to determine if there should be a small per-ride fee for the service to replace some or all of the public funding.
- The route is approximately 30 minutes, so it would be a 30-minute headway off-peak, and a 15minute headway during peak times. These are good headways for a service like this, as by comparison, large transit operations like subways aim for 10-minute headways, so this is quite good headway time for a service of this type.
- There is a chariot app that will allow residents to see the location of shuttles and the approximate time they will arrive at the stop, helping to reduce wait times at the stop by planning what time you leave the house or establishment you are at.
- The PR stops will be on Sylvan, either at Indiana or closer to Woodward, and at or near Hessel Park. These two stops put almost all east side residents within a 5-minute walk of the stop, and most west side residents are within a 10-minute walk of the stop. Refer to the preliminary route map on the following page.
- There is a possibility of the service migrating from fixed route to on-demand in the future. Chariot was set up as a fixed route shuttle service, but they are looking at an on-demand model, or at least a hybrid that brings in on-demand and fixed route elements.
- Finally, there is a possibility that the service will kick-off on Labor Day weekend as an Arts Beats and Eats shuttle like the trolley we used to run, with the regular fixed route service starting the weekend after Labor Day. For reference, we used to pay around \$3,000 for the one-weekend Labor Day trolley alone, while this Chariot partnership would be \$10,000 to access shuttle service for three days every weekend for 7 months, plus the potential for an Arts Beats and Eats shuttle.
- We have also discussed offering charter-style shuttle services for other events around the region during the pilot period. This is something that is still in development, so I don't have any details other than there may be special shuttles to things happening downtown or in Detroit or elsewhere.



Routing

Hope is to encompass E. And W. Pleasant Ridge, First United Methodist lot, Downtown Ferndale, Livernois, and SMART Woodward stops

Service Level

- 1 WAV vehicle running Thurs-Saturday, 4pm-12am
- Additional WAV vehicle during peak hours Thurs-Saturday, 5p-10pm
- Servicing outlying parking lots to encourage parking, and ease trips to downtown Ferndale during construction.

Future Growth

After an initial 6 month pilot the program will be reviewed. Chariot could launch additional routes based on public/private partnerships. Chariot will need to generate enough interest from the city, business, and public interests to make routes feasible.

Charter Services

Chariot can provide additional vehicles during downtown events throughout the summer and fall. Chariot will provide vehicles on an hourly basis, separately contracted.

Re: DDA Banners

Overview

The current DDA banners are approaching the end of their useful life. Staff would like to discuss the future of the banner program with the DDA.

Background

For context and information, the current banners cost \$7,450 to install in 2015. Since installation, we have spent about \$2,500 to maintain and replace banners that have fallen down or had brackets fail. There was also about \$1,000 of professional services cost to design the new banners.

Requested Action

A discussion to provide guidance to staff on how to handle the aging banners. Options include replacing the existing banners with the same design, replacing existing banners with a new design, keeping the current banners in place for as long as we can, removing the current banners without replacement, or another option identified during the discussion.
