Lauran: As we briefly discussed by phone, Lore a is a PR Foundation Trustee and she's deeply involved in arranging the Foundation's "virtual" auction in October. She asked me to make a request of the Historical Commission in light of the current work on PRTN 2:

The Foundation's virtual auction will include live auction and silent auction on a professional platform, interspersed with vigne es of the community. These vigne es will be professionally-produced inserts of maybe 3 minutes each, on a variety of local topics...accomplishments, entertainment, information. The cost of producing the vigne es will be borne by the Foundation, but the content needs to come from somewhere.

The Foundation suggested that the upcoming update of PRTN2 would merit a short vigne e, describing the project, describing PR's history, and maybe even showcasing history of the Foundation. I know we have images and narrative, and we can add appropriate commentary on top of that. I would be willing to help with that effort if the Commission wants. (I've done two Speakers Series in the past.) Plus, for promotion purposes, the timing of the auction might even align somewhat with the release of PRTN2.

>> Can you add this to your next agenda and ask if the Historical Commission supports this?
